

Historical Timeline of the Tribal Research Office



- In Oct 2013, Tribal Council passed a motion to establish an Internal Review Board to protect Tribal data and Tribal Government information.
- In June 2014, the SWO partnered with the Collaborative Research Center for American Indian Health (CRCAIH) to build and establish research infrastructure for our people.
- In Sept 2014 the SWO Local Research Review Board was established and began granting permission to researchers to conduct research on the LTR.
- In July 2015, Tribal Council Resolution (No. SWO-15-080, Motion #20) passed the Chapter 77, "Research Codes."



The map above represents the CRCAIH Tribal partners which include, SWO, Oglala Sioux Tribe, Rosebud Sioux Tribe, Turtle Mountain Band of Chippewa Indians in North Dakota and the Fond du Lac Band of Lake Superior Chippewa in Minnesota. Not only do these tribes continue to build their research infrastructure to fit their community, but each tribal partner provides support to one another which has been helpful in addition to the support from CRCAIH.

Mission

The current mission of the Sisseton-Wahpeton Oyate Research Office is to enhance the tribal research infrastructure by continuing to build the research review capacity, education through community engagement, and exercising tribal sovereignty through research data management. The main objective of the Tribal Research Office is to improve the overall status of all Tribal members through relevant, tailored, and culturally sensitive research as outlined in in the SWO Code Chapter 77 – "SWO Research Code."
